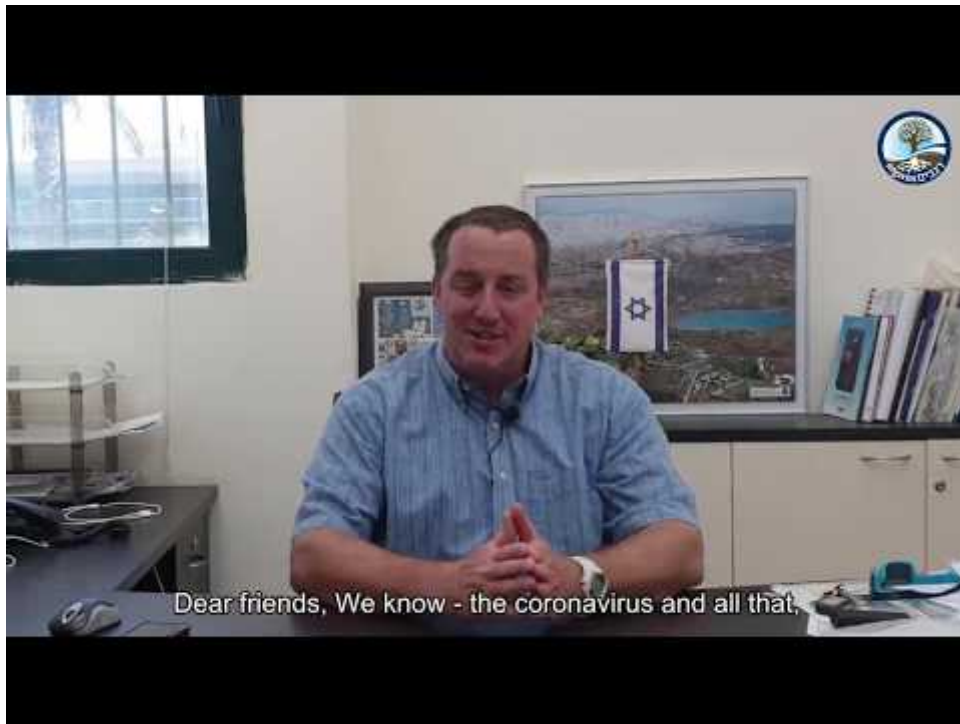

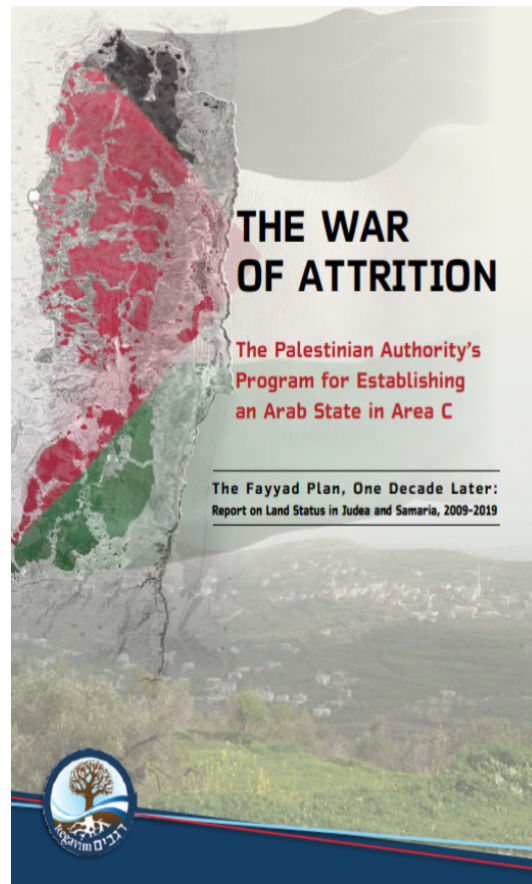
The War of Attrition
Regavim's Study of Land
Status in Judea and Samaria

Regavim's most recent research report analyzes the outcomes of The Fayyad Plan, a program for strategic takeover of Area C launched by the Palestinian Authority in 2009.

Our report provides a survey of data regarding tens of thousands of structures built illegally over the past decade, as well as data regarding illegal agricultural land-seizure projects covering hundreds of thousands of dunams of land, the program of "lawfare," funded by foreign interests and aimed at undermining Israeli law enforcement, as well as the clear and proven ties of these projects to internationally-sanctioned terrorist organizations.

The report's release led to the Ministry of Defense to classify activities to combat these dangers as "the strategic battle for Area C."

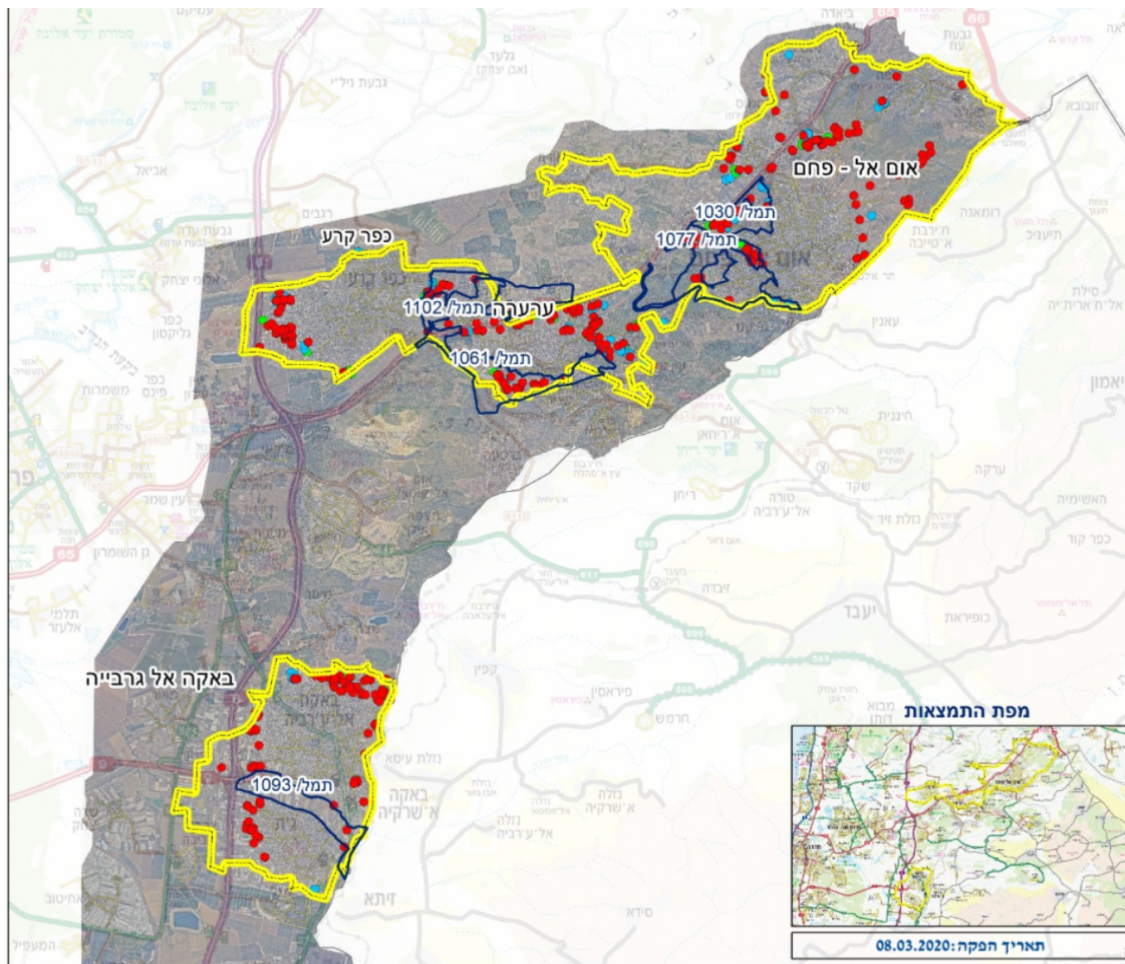

Regavim's Newest Department: Geographic Monitor



An all- new department was established at Regavim, tasked with monitoring the activities of local and regional Planning and Construction Boards (under the umbrella of the Planning Authority of the Ministry of Treasury), and Geographical Committees (which are, in turn, under the jurisdiction of the Ministry of Interior), in order to observe their activities in real time.

In the few months since the department became operational, the importance of this project has become clear: Our Monitoring Division is already hard at work, addressing a number of plans that have been advancing through the planning apparatus that would “whitewash” hundreds of illegally-built structures, as well as a number of cases involving the transfer of jurisdiction over large tracts of state land to the hands of planning authorities that do not enforce building codes.

Breakthrough in the Battle Against Polygamy

Regavim has been investigating and taking an active role in the fight against the practice of polygamy in Israel's Bedouin sector, devoting particular attention to the broader implications and outcomes.

after forcing this issue onto the government's agenda and bringing it to the top of the Ministry of Justice's action list, we have devoted ourselves to maintaining the pressure and capitalizing on the momentum in order to ensure that the government's decisions on this matter are implemented. As members of the Inter-ministerial Committee formed to combat polygamy, under the direction of the Director General of the Ministry of Justice, we continue to monitor

progress in each of the relevant authorities and ministries.

One of the major problems we raised – in the media and in the committee – is the issue of fraudulent National Insurance stipends that costs Israeli taxpayers over NIS 100 million each year. Since April 2019, the National Insurance Institute has not assigned a single staff member to investigation of fraudulent benefits claims in polygamous families.

We demanded that a number of investigative positions be set aside for Arabic-speaking investigators with the experience, training and tools to ensure that stipends are disbursed in full compliance with the law - and our demands have been met: 6 new investigators have begun their training, and 3 all-terrain vehicles have been purchased to facilitate their investigative work.
