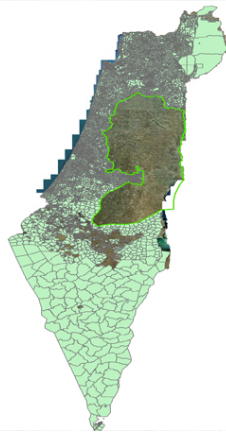

Petition to repeal the racist law prohibiting sale of land to Jews - The law passed by the Jordanian government in 1953 that prohibits the sale of land in Judea and Samaria to Jews - and only to Jews - is still in force today. At long last, Regavim has submitted a petition to the High Court of Justice to repeal this racist legislation. [See media coverage](#)

The Illegal School at Kochav HaShachar. As part of our fight against the illegal schools being built by the Palestinian Authority in Area C, we filed a new petition against the PA's new "confrontation school" in the Kochav HaShachar quarry. Follow press coverage [here](#)>>



The Bir Zeit Scrapyard. We petitioned the court regarding a gigantic, illegal automotive scrapyards near Bir Zeit, on land under Israeli jurisdiction (Area C), that is a major source of environmental damage caused by improper handling and disposal of toxic substances, fuel run-off and automotive effluents.



The Illegal Commercial Center at the Hizmeh Junction. At the northern entrance to Jerusalem, an illegal commercial and industrial hub has sprung up over the past few years, gradually growing to include dozens of storefronts built along the highway (Route 60). This commercial center is both a safety hazard and a daily nuisance, disrupting the flow of traffic at a very busy intersection and hindering Ministry of

Transports plans to expand this heavily traveled section of the road and the entrance to the capital.



Illegal Businesses at Luban a-Sharkiyeh. We filed a new petition against the illegal businesses built along the access road to Luban a-Sharkiyeh that pose a danger to motorists and pedestrians.



The Villa at Nabi Elias. After we received a series of laconic responses from the authorities regarding a huge illegal villa built outside the village of Nabi Elias, we petitioned the court to issue a demolition order for the structure, and demanded law enforcement in the area.
